- 1. I declare that I am over I8 years of age, and able to undertake complete responsibility for the dog and it's upkeep (including veterinary fees) and that such responsibility will not be transferred to another person without the prior written consent of S.T.E.C.S.
- 2. I acknowledge that I am aware that S.T.E.C.S does not sell dogs which come into their care for re-homing, and that these dogs remain under the protection of S.T.E.C.S for the duration of their lives. However to offset the cost of rescue, I agree to pay (if requested) a **minimum donation of £80.00** for dogs under the age of 10 years.
- 3. I will not part with the dog (other than temporarily for the purpose of holidays) nor make any change of ownership of the dog whatsoever without first consulting S.T.E.C.S.
- 4. If a situation should arise whereby at any time I can no longer care for the dog, I will immediately notify S.T.E.C.S and in that event S.T.E.C.S shall be entitled to take the dog back into their care.
- 5. Unless, age, ill health or veterinary advice dictates otherwise, I agree to have the dog neutered. If not already neutured I understand that S.T.E.C.S can offer assistance with the cost of neutering. S.T.E.C.S forbid the use of dogs for breeding purposes, and neutering ensures dogs can not be mated and also prevents several potentially fatal conditions
- 6. I will keep the dog in proper indoors quarters and should it appear ill at any time I will immediately seek the advice of a qualified Veterinary Surgeon.
- 7. I will at any reasonable time permit and allow the authorised Representative of S.T.E.C.S access to inspect the dog and its living quarters, and I agree that if conditions are unsatisfactory for the dog, then S.T.E.C.S shall have the right to reclaim the dog immediately and to retake possession and ownership forthwith.
- 8. I undertake to have the dog protected at all times against major canine diseases by annual vaccination booster.
- 9. I undertake not to have the dog adopted or destroyed under any circumstances unless either I have first obtained and received the prior consent in writing of S.T.E.C.S, or alternatively the advice of a qualified Veterinary Surgeon that it is essential so to do to prevent unnecessary suffering to the dog.
- 10. I undertake that the dog will wear a collar and name disc at all times, and will not in any circumstances be allowed outside my home unaccompanied save in my completely fenced garden / yard.
- 11. I understand that it is strongly recommended by S.T.E.C.S that the adopted dog be insured by the adoptee against veterinary bills.
- 12. I understand that as far as is known to S.T.E.C.S, the dog is healthy or that S.T.E.C.S has advised me of any known health problems, but that S.T.E.C.S cannot guarantee that health problems will not arise in the future.
- 13. I undertake to have my adopted dog regularly trimmed and kept in a clean condition at all times.
- 14. I understand that I am responsible for the behaviour and control of the dog at all times, both in the presence of people and other animals.
- 15.I will notify S.T.E.C.S of any change of address.
